La mayoría de los capítulos de este libro fueron modelados a partir de recuentos orales que escuché y recopilé mientras hacía mi trabajo de campo. El trabajo de campo entre los satnamis fue realizado a lo largo de varios meses comenzando a finales de la década de los ochenta y terminando a mediados de los noventa. El trabajo de campo relativo a los aspectos del encuentro evangélico fue realizado entre indios conversos al cristianismo en Chhattisgarh en el invierno de 1994-1995 y en marzo de 1996, y entre misioneros norteamericanos y sus descendientes en Goshen, Indiana, y Newton, Kansas, entre agosto y octubre de 1993 y en abril de 1997. El trabajo de campo relativo a los aspectos de la ley y las legalidades se llevó a cabo en Chhattisgarh entre noviembre de 1989 y abril de 1990. El trabajo de campo entre los partidarios de clase media de la Hindutva se realizó principalmente en Nagpur en los meses de octubre y noviembre de 1994 y en septiembre de 1998.
